- **Ways to make changes:**
 - Identify the leadership of the organization that is giving you trouble
 - Join your local American Legion Post, VFW Posts, and other Veteran Cannabis Advocate groups
- **Medical Doctors Recommendation**
 - Universally recognized doctor recommendation across states: Reciprocity
 - Current states with reciprocity: Michigan, Vermont..?
 - **Veterans should be able to use their doctors rec in any state that has a medical cannabis program**
 - Medical records - if your records indicate a qualifying condition for medical cannabis
 - IL - bring your medical records to the Health Dept. and they will issue you a free medical recommendation.
 - Gun issue when you are registered to any State's medical cannabis program
- **Consumption - Vaporizing/Flower/Etc.**
 - Definition of a cannabis product's chemical composition is the first required milestone toward enabling rigorous scientific evaluation of cannabis. Flower cannot be defined this way as it is not a uniform substance. Concentrate is & can be defined this way.

- **V.A. Issues New Medical Marijuana Policy For Military Veterans;**

The directive urges government doctors to "discuss with the Veteran marijuana use, due to its clinical relevance to patient care, and discuss marijuana use with any Veterans requesting information about marijuana."

However, the policy reiterates the department's long-held position that "to comply with Federal laws such as the Controlled Substances Act...providers are prohibited from completing forms or registering Veterans for participation in a State-approved marijuana program."
